For decades, the Clery Act (20 U.S.C. § 1092(f)) has governed reporting requirements for crimes on campuses at colleges and universities, requiring that these higher education institutions report campus crime data, support victims of violence, and publicly outline the policies and procedures they use for campus safety. The Act supports transparency, as well as properly warning staff and students of an ongoing crime in a timely fashion.

As a single-pane-of-glass security and notification solution, 911inform's emergency notifications upgrade a facility to be compliant with the Clery Act's timely warnings and emergency notifications requirements. When a 911 call is detected within a campus, or a hard or soft panic button is hit, 911inform instantly delivers notifications over text message or email to all relevant user devices. Keeping approximately 19 million post-secondary students safe across the United States is no small feat. Higher education institutions are responsible for student safety, partially through notifying students of any ongoing emergency. The Clery Act (20 U.S.C. § 1092 (f)) has governed reporting requirements for crimes on campuses at colleges and universities for decades. Read on for facts regarding the Clery Act and institutional reporting requirements.

- The Clery Act was passed in 1990 and applies to all colleges, universities, and other post-secondary institutions.
- The Clery Act is intended to provide transparency around campus crime policy and statistics.
- Key points of the Clery Act include:
 - Annual security reporting
 - Organizing data into crime categories
 - Reporting crimes based on geography and availability
 - Providing timely warnings and emergency notifications
 - Supporting victim rights, options, and resources.
- Crimes covered by the Clery Act:
 - Criminal offenses, like criminal homicide, manslaughter, sexual assault, robbery, aggravated assault, burglary, motor vehicle theft, and arson
 - Hate crimes, including larceny, simple assault, intimidation, destruction of property or vandalism
 - VAWA offenses, including domestic violence, dating violence, and stalking
 - Arrests and referrals for disciplinary action, including weapons law violations, drug abuse, or liquor offenses.
- Locations Covered by the Clery Act's Reporting and Notification Guidelines:
 - On-campus
 - On-campus student housing
 - Public property within campus property
 - Public property immediately adjacent to campus property
 - Non-campus buildings and property owned by or controlled by the organization or officially recognized student organizations.
- Timely Warnings and Emergency Notifications
 - Campus officials are required to alert students of the occurrence of any of the covered crimes if they present a threat to the campus community
 - Notifications can be sent to the entire campus, or limited to a specific area.
